Sub: Drawal of pay of Surplus lecturers working on Academic requirement, Court cases and Medical grounds (Life consuming).

ORDER

Whereas, many representations have been received in this Directorate regarding non drawal of salary of some lecturers of Jammu Division working as Surplus, Academic requirement, Court Cases and Medical grounds (life consuming), and;

Whereas, 261 Lecturers have already been allotted vacant posts of lecturers for drawal of their salaries vide this office Order No 790-DSEJ of 2018 dated 08-11-2018, and;

Whereas, among these Lecturers some Lecturers with disability conditions and at the verge of retirement have also not been able to draw their salary for the last few months, and;

Whereas, it imperative to adjust these Lecturers against substantive posts and the exercise for which is being already undertaken, and;

Whereas, in the mean time, salary needs to be disbursed to them which has been pending for the last few months and causing serious financial crisis for such Lecturers.

Therefore, in view of the difficulties being faced by these Lecturers, a list of such Lecturers indicating the posts now allotted strictly for the purpose of drawal of salary for the period shown against each till they are adjusted against substantive posts whichever is earlier.

- 2 All Lecturers who have already been allotted posts vide earlier order shall send their LPC, attendance certificate and other relevant papers along with service book to the concerned DDO, if they have not already done so, so that their salary can be drawn and disbursed.
- 3 The concerned Drawing and Disbursing Officer shall draw the salary in favour of the Lecturers after observing all the codal formalities as required under rules in accordance with the instructions of circular No. 104-F of 2018 dated 27-03-2018 and the allowances shall be regulated as admissible.
