

Notification
Srinagar, the 2nd September, 2021

WHEREAS, Section 89 of the Jammu and Kashmir Reorganization Act, 2019, contains 'provisions relating to services' (manpower) other than the All India Services of erstwhile State of Jammu and Kashmir and their provisional continuance in the successor Union territories namely, Jammu & Kashmir and Ladakh, sub-Section (1) whereof provides, as under:-

"89(1) Every person who immediately before the appointed day is serving on substantive basis in connection with the affairs of the existing State of Jammu and Kashmir shall, on and from that day provisionally continue to serve in connection with the affairs of the Union territory of Jammu and Kashmir and Union territory of Ladakh, by general or special order of the Lieutenant Governor of Union territory of Jammu and Kashmir;

Provided that every direction under this sub-section issued after the expiry of a period of one year from the appointed day shall be issued with the consultation of the Government or Administration of the successor Union Territories, as the case may be."

AND WHEREAS, sub-Section 2 of Section 89 of the said Act provides for determination of the successor Union territory to which every employee/person falling under the ambit of the Sub Section (1) of Section 89 of the Jammu and Kashmir Reorganization Act, 2019 shall be finally allotted for service; the relevant provisions whereof are reproduced as under:-

"89(2) As soon as may be after the appointed day, the Lieutenant Governor of Jammu and Kashmir shall, by general or special order, determine the successor Union territory to which every person referred to in sub section (1) shall be finally allotted for service, after consideration of option received by seeking option from the employees, and the date with effect from which such allotment shall take effect or be deemed to have taken effect:

Provided that even after the allocation has been made, Lieutenant Governor of Union territory of Jammu and Kashmir may in order to meet any deficiency in the service, depute officers from one successor Union territory to the other Union territory."


AND WHEREAS, pursuant to statutory obligation contained under Section 89(2) of the Jammu and Kashmir Reorganization Act, 2019, options with regard to allocation of Union territory were sought from all employees of the erstwhile State of Jammu and Kashmir serving on substantive basis, on prescribed proforma notified vide Circular No. 42-GAD of 2019 dated 11.10.2019;

AND WHEREAS, in order to provide a single platform for obtaining the option data of all employees referred in Section 89(1) of the Jammu and Kashmir Reorganization Act, 2019, the Information Technology Department developed an 'Option Application' and all Administrative Departments were instructed to enter option data in respect of their employees from respective logins in the 'Application' through web-link 'empseva.jk.gov.in';

AND WHEREAS, during analysis of option data provided by the Administrative Departments in the 'empseva application', some variations, including incomplete credentials of employees were observed, consequent upon which, all the Administrative Departments were requested to re-verify the option data pertaining to the employees of their Department, which has now been done ;

AND WHEREAS, it is has been decided to apportion the manpower, by allocating the employees opting to serve in Union territory of Ladakh to said Union territory and remaining employees to Union territory of Jammu and Kashmir, in the first phase;

AND WHEREAS, before the matter is placed before the Competent Authority, it has been decided that the details of employees who have opted for serving in the Union territory of Ladakh and domicile employees of Union territory of Ladakh who have opted to serve in the Union territory of Jammu and Kashmir, shall be given an opportunity to verify their option details/credentials;

 **NOW THEREFORE**, in order to provide an opportunity to the employees for verification of their particulars including option exercised for serving in the successor Union territories, the details of employees having opted to serve in the Union territory of Ladakh and the domicile employees of Ladakh having opted to serve in Union territory of J&K, provided in **Annexure-A & B respectively**, are hereby notified for the information of all concerned. The Administrative Departments shall also verify these details to ensure that no employee is left out of the exercise of apportionment to Union territory of Ladakh.

In case of any variation, grievance, change/alteration required to be effected, such employees are hereby informed to submit their representation duly endorsed by their controlling officers to their respective Administrative Departments within five (05) days of this notification. The Administrative Departments shall verify the same and provide the consolidated information to General Administration Department, J&K as per proforma provided at **Annexure-'C'** of this Notification within two (02) days thereafter positively, through email 'servicessection226@gmail.com'.


