**ORDER NO: 930 DSEJ of 2021**

As per the approval conveyed by the Administrative Department vide letter No. Edu-NCSE/278/2021-05 dated: 23-10-2021, sanction is hereby accorded to the temporary appointment of Smt. Aradhna Mehra W/o Late Sh. Deepak Chand (Deceased) R/o: Batmalloo, Srinagar A/P: H.No. 38/5, Patoli Mangotrian Jammu as Junior Assistant in the Pay Level SL 4 (25500-81100) in the School Education Department in District Jammu under SRO-43 of 1994 on the basis of peculiar circumstances involved in the matter, with the direction that applicant shall acquire technical qualification subsequently required for the post.

The appointee shall report to the Chief Education Officer, Jammu within a period of twenty one days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates:

1. Academic Qualification Certificates.
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Health Certificate from the concerned Chief Medical Officer of the District.
5. Dependent Certificate issued by the Assistant Commissioner Revenue.
6. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
7. All other relevant documents as are required under SRO-43/1994.


The appointment of the appointee shall further be subject to the following conditions:-

- (a) That she shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate 1<sup>st</sup> class to the effect that, If on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Junior Assistant shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.
- (b) The appointee shall be initially on probation for a period of two years.
- (c) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.



- (d) If the appointee fails to join within a period of 21 ( twenty one) days from the date of issuance of this order she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

This order is, however, subject to outcome of writ petition (s) if any, pending in any competent Court of Law.
