Sanction is hereby accorded to the temporary appointment of Mr.Tarun Abrol S/o Late Sh. Rajesh Kumar (Ex-Master) Govt. Middle School Thaplal, R/o Village/Street Ramnagar, P.O. Ramnagar, Tehsil Ramnagar & District Udhampur under SRO-43 of 1994 as **Multitasking Staff (Lab. Bearer)** lying vacant at **Govt. Hr. Sec. School Rang**, Zone Ramnagar in the Pay Level SL-1 (14800-47100) in the School Education Department in District Udhampur under SRO-43 of 1994 after receipt of satisfactory verification report from Spl. Director General CID vide letter quoted under reference and in pursuance to Govt. Order No. 528-JK(GAD) of 2021 dt.21.06.2021.

The appointee shall report to the Chief Education Officer, Udhampur within a period of twenty one days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates;


1. Academic Qualification Certificate.
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Health Certificate from the concerned Chief Medical Officer of the District.
5. Dependent Certificate issued by the Assistant Commissioner Revenue.
6. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
7. All other relevant documents as are required under SRO-43/1994.

The appointment of the appointee, shall further be subject to the following conditions:-

- a) That he will give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate, 1<sup>st</sup> Class to the effect that if on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as **MTS** shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against the applicant.

- b) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) above is received in his favour.
- c) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- d) The appointment of the candidate shall be governed in terms of Jammu and Kashmir (Condition of Service, Pay and allowance and fixation of tenure rules, 2020 notified vide S.R.O. 192 of 2020 dt. 17.06.2020).
- e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

This order is, however, subject to outcome of writ petition(s) if any, pending in any competent Court of Law.
