- That no Higher standard pay-scale shall be granted to the employee who is under suspension on the date of eligibility or who is charge- sheeted under provision of J&K classification control and appeal rules or any other rules for the purposes;
- That such period of leave without allowances as had not been agreed to by the competent authority to be counted for purpose of annual increment shall not be taken into account for reckoning of the period of 9/18/27 years for Higher standard pay-scale as the case may be;
- 3. That the benefit of promotion shall not be given to such employee, who relinquishes promotion for reasons what so ever;
- That the work and conduct of the concerned eligible employees has remained satisfactory as per APR's together with result for preceding three years;
