#### CIRCULAR

In terms of circular is ued vide Endorsement No:- DSEJ/Pvt/2022/2436-2569 dated 27-04-2022 detailed instructions have been issued for streamlining the process o confirmation of results by the Chief Education Officers/ZEO's etc. The said circular inter alia provides that the result of only those classes shall be confirmed/countersigned for which the school is recognized/permitted by the competent authority or for which classes it is recognized/permitted.

In this context, repre entations have been received from some parents of the students studying in schools/classes where result has not been confirmed requesting for reconsideration of these guidelines so that the future of their wards is not affected adversely. The matter has therefore, been reviewed and it has been fell appropriate to issue further instructions.

It is enjoined upon all the schools to display the recognition and affiliation status issued by competent authority on their sign boards. Parents should also ensure that the schools in which their wards are seeking admission are recognized affiliated by Director School Education/ Chief Education Officer/ JK BOSE/ BSE etc. as the case may be.

All schools where results could not be confirmed due to pending recognition / affiliation are enjoined upon to complete all requirements and apply for the same through the online portal immediately, the link of which is available on the websites of the School Education Department as well as the Directorate of the School Education, Jammu.

#### CIRCULAR

In supersession of all previous orders/ instructions on the subject and in order to streamline the process of confirmation of results by the Chief Education Officers / ZEO's on a uniform pattern, the following parameters shall henceforth be adopted for countersigning the results:

- ZEO shall countersign the results for Private Middle Schools in their respective jurisdictions.
- b. CEO's/Dy. CEO's (where applicable) shall countersign results for Private High/Higher Secondary Schools in their respective jurisdictions.
- The Private Schools shall be required to produce the countersigned result of C. the previous academic year alongwith the proof of recognition of the School.
- d. The current result will be countersigned only, if the students figuring therein have same particulars as that of previous academic year and have unique ID of Adharshila portal.
- Authenticated/Countersigned School Leaving Transfer Certificate of the previous School shall be required only in case a student is figuring in the current result but he/she does not figure in the countersigned result of the previous year.
- f. Birth Certificate as Proof must be asked/seen in case of the result of standard
- g. The result of only those classes shall be confirmed/countersigned for which the School is recognized/permitted by the competent authority or for which classes it is recognized/perm tted.
- The result countersigning authorities shall maintain a proper datah. base/record of the schools whose result is confirmed/countersigned.
- After countersignatures at schools must upload the results on the Aadharshila portal.

All the concerned CEO's are as such enjoined to pass on the instructions to the ZEO's for strict implementation
