2. This order shall be valid only for drawing the salary upto the month of Feb. 2019 or as shown against each or till adjusted against substantive post and the concerned DDO after the receipt of attendance certificate from the DDO where above mentioned masters are presently working shall draw and disburse the salary after observing all the codal formalities as required under rules.
3. Drawing and Disbursing Officers having posts of RMSA now merged in the School Education Department vide Govt. Order No. 19-Edu of 2019 dated 22-01-2019 shall immediately project the requisition of funds for drawing the salary of Masters.
4. All masters who have already been allotted posts vide earlier order shall send their LPC along with service book to the concerned DDO if they have not already done so that their salary can drawn and disbursed.
