Sub: Review of suspension case of Sh. Devinder Kumar, Peon DIET Jammu and decision thereof.

ORDER

Whereas, vide Government Order No. 223-Edu of 2017 dated 16-05-2017, a Review Committee was constituted to review the suspension of non-gazetted employees of School Education Department; and

Whereas, Sh. Devinder Kumar, Peon, DIET Jammu was placed under suspension by CEO Jammu vide order No. CEOJ/25960-63 dated 15-09-2016 and directed to report to the office of ZEO Chowki Choura, Jammu; and

Whereas, the said official was suspended after being arrested in a case FIR No.150/16 u/s 294 RPC was registered against him at Police Station, Bakshi Nagar, Jammu; and

Whereas, a complaint was also lodged against him by one lady Lecturer of DIET Jammu for harassment, mis-behaviour and blackmailing; and

Whereas, Principal, DIET Jammu vide No.DIET/J/1127 dated 26-11-2021 has recommended for the reinstatement of the official who is under suspension for the last five years; and

Whereas, CEO Jammu vide communication No.CEOJ/31573 dated 10-01-2022 has forwarded the list of suspendees wherein the name of the official is figuring at S.No.13.

Whereas, the case of the peon was placed before the Review Committee which met in the Directorate on 20-01-2022 under the chairmanship of Director School Education, Jammu and after threadbare discussions/ deliberations in the instant case, the Committee made the following recommendations:-

"The Committee considered the case and decided to reinstate the official which will remain subject to the outcome of criminal case FIR 150/2016 as the official is under suspension for more than five years and prolonged suspension is bad in the eyes of law. However, CEO Jammu shall take an undertaking from the concerned official to the effect that he will perform his duties with dedication and sincerity. His period of suspension shall be decided lateron".

Now, therefore in view of the recommendations of the Review Committee, CEO Jammu is directed to take further appropriate action as per the recommendations of the Review Committee under an intimation to this Directorate.
