Sub: Review of suspension case of Sh. Mohd. Amin, Teacher, Government Primary School, Tarasera, Zone Mahore, District Reasi and decision thereof.

ORDER

Whereas, vide Government Order No. 223-Edu of 2017 dated 16-05-2017, a Review Committee was constituted to review the suspension of non-gazetted employees of School Education Deptt.; and

Whereas, Sh. Mohd. Amin, Teacher, Government Primary School, Tarasera, Zone Mahore, District Reasi was placed under suspension and attached in CEO Office by CEO Reasi vide order No. CEO/Rsi/Esstt/3901-03 dated 24-08-2021 after some video clip went viral on social media where he was found consuming intoxicating drugs; and

Whereas, the Enquiry Committee constituted for the purpose submitted its report stating therein that the official seemed to have consumed absurd material but it was not clear that he consumed the drugs himself or was administered by some persons on rivalry basis as he claimed that the drugs were given to him mixed with cold drinks by his enemies and he was not aware of the fact; and

Whereas, CEO Reasi vide letter dated 05-01-2022 has requested for the reinstatement of the official and has stated that the said official has not been found indulging in such activity which could prove that he is using drugs besides he has given an undertaking in the form of affidavit duly attested by Magistrate that he will remain vigilant in future and has requested for his reinstatement so that he can feed his family; and

Whereas, the case of the Teacher was placed before the Review Committee which met in the Directorate on 20-01-2022 under the chairmanship of Director School Education, Jammu and after threadbare discussions/ deliberations in the instant case, the Committee made the following recommendations:-

"The Committee considered the case and decided to reinstate the official by serving with a censure to him. His period of suspension will be decided lateron".

Now, therefore in view of the recommendations of the Review Committee Sh. Mohd. Amin, Teacher is hereby reinstated and CEO Reasi will censure the

official under an intimation to this Directorate and his period of suspension will be decided lateron.
