**Sub: Review of suspension case of Sh. Lal Din, Senior Assistant, Government Higher Secondary School, Chakroi, District Jammu and decision thereof.**

**ORDER**

Whereas, vide Government Order No. 223-Edu of 2017 dated 16-05-2017, a Review Committee was constituted to review the suspension of non-gazetted employees of School Education Department; and

Whereas, Sh. Lal Din, Senior Assistant, Government Higher Secondary School, Chakroi, District Jammu was placed under suspension by CEO Jammu vide order No. CEOJ/MW/28275-79 dated 30-08-2018 after his arrest on 23-08-2018 for his involvement in a case FIR No. 74/18 u/s, 307/34 RPC 4/24 Arms Act registered at Police Station Gangyal. He was attached in the office of ZEO Marh; and

Whereas, the said official has requested for his reinstatement keeping in view that he has already attained the age of superannuation and his pension case is also not settled beside he is suffering multifarious kinds of ailments; and

Whereas, the CEO Jammu vide communication No. CEOJ/31573 dated 10-01-2022 forwarded the list of suspendees wherein the name of the official was figuring at S.No.10; and

Whereas, the case of the Senior Assistant was placed before the Review Committee which met in the Directorate on 20-01-2022 under the chairmanship of Director School Education, Jammu and after threadbare discussions/ deliberations in the instant case, the Committee made the following recommendations:-

***“The matter was discussed by Sh. Javid Ahmed Shagoo, Additional Secretary (L), School Education Department with Law Secretary personally who advised that since now the employee has retired so there is no need to reinstate him. The Department can proceed ahead in the matter by settlement of his provisional pension subject to outcome of the criminal proceedings pending before the Hon’ble Court as has been held by the Hon’ble Court in the case titled D.D.Suri V/s A.K. Barren & ors. (AIR 1976) SC 1069”.***



Now, therefore in view of the recommendations of the Review Committee, CEO Jammu is directed to take further appropriate action as per the recommendations of the Review Committee and shall furnish the action taken report to this office.
