Sub: Review of suspension case of Late Liaquat Ali, Teacher, Government MPS Bela Jodh, Zone Barnoti, District Kathua and decision thereof.

ORDER

Whereas, vide Government Order No. 223-Edu of 2017 dated 16-05-2017, a Review Committee was constituted to review the suspension of non-gazetted employees of School Education Department; and

Whereas, Late Liaquat Ali, Teacher, Government MPS Bela Jodh, Zone Barnoti, District Kathua was placed under suspension by CEO Kathua vide order No. CEOK/2176-79 dated 18-04-2017 after his arrest on 16-04-2017 for his involvement in a case FIR No. 43/17 u/s 8/15 NDPS Act in Police Station Hira Nagar; and

Whereas, Hon'ble Special Judge, District Court Kathua on 30-12-2017 released him on bail and CEO Kathua vide No. CEOK/legal/ 39240-42 dated 01-01-2018 attached him in the office of ZEO Office Barnoti; and

Whereas, ZEO Barnoti vide No. ZEOB/416 dated 25-05-2021 has informed that the said Teacher died on 12-05-2021; and

Whereas, CEO Kathua vide letter No. CEOK/legal/17167-68 dated 10-01-2022 has stated that ZEO Barnoti vide letter dated 18-11-2021 has forwarded the representation of Shamshad Bibi W/o. Late Liaquat Ali for the drawl of salary/balance payment; and

Whereas, it is in place to mention here that Hon'ble Principal Sessions Judge Kathua vide order dated 09-11-2021 has issued the following directions:-

"Accused No.1 absent, Shafi, the father of the accused No.1 has produced death certificate in original issued by P/S Rajbagh. After retaining the photocopy of the original death certificate has been returned to the said Mohd. Shafi. The court is satisfied from the contents of the death certificate that the accused No.1 died on 12-05-2021. As such prosecution abates against the accused No.1. File be consigned to records till the appearance of the accused No.2".

Whereas, the case of the Teacher was placed before the Review Committee which met in the Directorate on 20-01-2022 under the chairmanship of Director School Education, Jammu and after threadbare discussions/ deliberations in the instant case, the Committee made the following recommendations:-

"The Committee considered the case in light of the Hon'ble Court order dated 09-11-2021 and decided to ask CEO Kathua to proceed as per 108 (B) of CSR besides taking an undertaking from the legal heir of the deceased employee".

Now, therefore in view of the recommendations of the Review Committee CEO Kathua is directed to proceed as per 108 (B) of CSR besides taking an undertaking from the legal heir of the deceased employee".
