- That the work and conduct of the concerned eligible employees has remained satisfactory as per A'PR's together with result for preceding three years;

That if there is any case against of the official included in the sanction order pending in the department/Vigilance Deptt./Court of Law, the Situ promotion granted in such case should not be implemented and his/her case be referred to this Directorate for cancellation of his/her Situ promotion immediately.
