- 7. All other relevant documents as are required under SRO-43/1994.

The appointment shall be further subject to the following conditions:-

- a) That he will give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate, 1<sup>st</sup> Class to the effect that if on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as **MTS** shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against the applicant.
- b) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) above is received in his favour.
- c) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- d) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
