The concerned Drawing & Disbursing Officer(s) [DDOs] shall obtain an undertaking in the shape of an affidavit duly attested by the 1st Class Magistrate to the effect that if the service particulars / PG degree certificate is found fake/forged/tempered or issued by un-recognized University or if the course is proved to been un-recognized at a later stage, he/she shall have no claim, whatsoever, and the promotion shall be deemed to be treated as cancelled ab-initio, without further notice. The DDOs shall be personally responsible for implementation of the conditions ibid.
