Whereas, vide communication No. DSEK/Estt-I/1244 dated 24.02.2018, Director School Education, Kashmir forwarded application along with relevant documents of Mr. Bashir Ahmad, Lecturer (Botany) HSS Attina Budgam, stating therein that his junior counterparts have been placed as Sr. Lecturers whileas he is still working as Lecturer;

Whereas, Mr. Bashir Ahmad Sheikh, in his representation has requested that formal orders with regard to fixation of seniority as Lecturer is yet to be issued in light of Government Order No. 1073-Edu of 2013 dated 30.12.2013;

Whereas, the case has been examined and processed in the Department and vide notice dated 25.04.2019, objections were invited from concerned cadre members to fix the seniority of Mr. Bashir Ahmad Sheikh at 805-A in the final updated seniority list of +2 Lecturers of School Education Department issued vide Government Order No. 1073-Edu of 2013 dated 30.12.2013.
