Whereas, the Departmental Promotion Committee meetings was held on 08-02-2014 under the Chairmanship of the then Director School Education, Jammu; and

Whereas, DPC examined the promotion cases of trained graduate/Post graduate teachers and cleared promotion of 1193 teachers as masters including dropout cases; and

Whereas, the promotion orders of trained graduate/Post graduate teachers (male/female) as masters in the grade of Rs. 93000-34800 (Revised) + grade pay ors. 4280 was issued vide order No. DSEJ/NG/M/Prom/7255-68 dated 11-02-2014; vand

Whereas, a meeting was held in the Administrative Department on 10-11-2016, wherein it was decided that an updated seniority list of Trained Graduate/Post Graduate teachers as on 01-01-2014 is required to be put in the public domain for inviting objections; and

Whereas vide Govt. Order No: 940-Edu of 2017 dated 17-11-2017 that a mechanism has been devised by the School Education Department regarding verification of degrees obtained through Distance mode; and

Whereas, the Administrative Department vide letter No. Edu/II/57/2015 dated 22-12-2017 advised to apply the Department specific mechanism as devised vide Govt. Order No: 940-Edu of 2017 dated: 17-11-2017 for verification of Distance Mode Degrees of In-service candidates (Masters/Teachers) and dispose of all pending cases accordingly; and

Whereas, as per Point No. V of G.O No. 940-Edu of 2017 dated: 17-11-2017, the in-service candidates who have obtained degrees in B.Ed/M.Ed course through distance mode form University of Kashmir/Jammu/IGNOU or any other UGC-recognized university shall be considered as valid degree for effecting their promotion provided these degrees are also DEC approved; and,

Whereas, a committee of five members was constituted vide order No. 824-DSEJ of 2021 dated 01-10-2021 for verification of Degrees and Qualification Certificate of Master/Teachers.

Now in view of the recommendations of the committee, the following five teachers who have been promoted as master in the DPC of 2014 issued under No. DSEJ/NG/M/Prom/7255-68 dated 11-02-2014 are hereby adjusted as masters in the schools as shown against each:-
