- 3. Domicile Certificate.
- 4. Current Marital Status.
- 5. Health Certificate from the concerned Chief Medical Officer of the District.
- 6. Dependent Certificate issued by the Assistant Commissioner Revenue.
- No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
- 8. All other relevant documents as are required under SRO-43/1994.

 The appointment shall further be subject to the following conditions:-
- a) That she will give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate, 1st Class to the effect that if on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as **MTS** shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against the applicant.

b) The salary of the appointed shall not be drawn and disbursed to her unless a Satisfactory report in respect of (a) above is received in her favour.

C) The appointment of the candidate shall be governed by the "New Pension

Scheme" as per SRO-400 of 2009 dated 24.12.2009.

d) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

e) This order is issued in pursuance to rule 18(C) of S.O. 429 i.e. Jammu and Kashmir Rehabilitation Assistance Scheme 2022 issued vide notification dt.

06.09.2022.
