Whereas, a complaint has been received from Anti Corruption Bureau Jammu vide letter No. ACB-Edu-NG-30/21-9761-62 dated 20-05-2021 against Mtr. Shamshad Begum (Master) posted as warden KGBV Bajohi (Malhar) District Kathua regarding getting promotion on manipulated grounds; and

Whereas, vide this office letter No. DSEJ/MW/V-442/23562-64 dated 29-07-2021 CEO Kathua was asked to enquire the contents of the complaint & furnish detailed report along with his specific comments/recommendations; and

Whereas, Chief Education Officer, Kathua vide letter No. CEOK/74500-01 dated 09-08-2021 has reported that Smt. Shamshad Begum D/o Mohd. Wani R/o Thall (Lohai) was appointed as RET and adjusted in newly opened Primary School Kharkhana Zone Malhar vide ZEO Malhar's No. ZEOM/814-17 dated 22-03-2003 and joined there on 01-04-2003; and

Whereas, the said RET was regularized w.e.f 31-03-2008 after completing five years service as RET vide order No. 10-DSEJ of 2009 dated 17-10-2009 and CEO Kathua's No. CEOK/SSA/RET/10999-11011 dated 26-02-2009 and;

Whereas, the said RET was promoted as Master vide this office order No. DSEJ/NG/M/Prom/7255-68 dated 11-02-2014 under RBA Category on the basis of the service particulars as under:



Whereas, the trained graduate teachers/post graduate teachers whose date of appointment was on or before 09-11-2005 under RBA Category were promoted as Master; and

Whereas, the date of appointment/regularization of Mtr. Shamshad Begum as teacher is after 09-11-2005 i.e. cutoff date of trained graduate/post graduate teachers promoted as Master by this office order under RBA Category and she has been wrongly promoted as Master as her date of Ist appointment as RET is 22-03-2003 and RRET as 31-03-2008; and

Keeping in view of above facts, the promotion of Mtr. Shamshad Begum Warden KGBP promoted as Master vide this office order No. DSEJ/NG/M/Prom/7255-68 dated 11-02-2014 is hereby cancelled abnatio. She shall report to CEO Kathua for further adjustment in the institution where she was engaged as RET besides this CEO Kathua shall calculate the amount as she has drawn as Master shall deposit the same in Treasury under intimation to this office and necessary entries shall be made in her service book/record.
