Whereas, Chief Education Officer, Samba vide No. CEOS/NG/15671-72 Dated:-10.02.2017 was submitted a compassionate appointment case of Sachin Nayar S/o Late Sh. Rajinder Kumar (Ex- Safaiwala) GHS Birpur Zone Vijaypur, R/o Ward No. 04, Dogra Hall Jammu in terms of SRO-43 of 1994, and;

Whereas, the applicant has applied for considering his compassionate appointment under SRO-43 of 1994 with qualification 7<sup>th</sup> passed in lieu of death of his father (died on 02.09.2014); and

Whereas vide this office letter No. DSEJ/Gen/SRO-43/71195 dated:- 01.03.2017, Chief Education Officer Samba was asked to clarify the reason for late submission of the case and also to inform the applicant that his case is not covered under norms of SRO-43/1994 as the minimum qualification should be matriculation for entry into the Govt. Service; and

Whereas Administrative Department vide letter No. Edu-II/31/SRO/2020 dated:-21.01.2021 on the representation of applicant has desired to examine the case of the applicant under rules in vogue; and

Whereas vide this office letter No. DSEJ/NG/SRO-43/19633-34 dated:- 21.06.2021, Chief Education Officer Samba was asked to clarify the applying date of the applicant and also to furnish the requisite supporting documents along with specific comments in the matter, DDO attested copy of Legal Heir certificate, DDO attested copy of improved qualification certificates and DDO attested copy of Domicile certificate; and

Whereas Chief Education Officer, Samba vide letter No. CEOS/3725 dated:- 23.06.2021 has submitted DDO attested copy of legal Heir decree, DDO attested copy of Domicile certificate, DDO attested copy of the applying date of the applicant and DDO attested copy of 8<sup>th</sup> passed marks certificate/School leaving certificate of the applicant; and



Whereas vide this office letter No. DSEJ/NG/SRO-43/23855-56 dated:- 02.08.2021, Chief Education Officer Samba was asked to verify the authenticity of two school leaving certificates and submit a detailed report along with specific comments accordingly; and

Whereas Chief Education Officer, Samba vide letter No. CEOS/NG/20014 dt. 27.02.2023 has submitted that the Headmaster GGHS Birpur Samba vide letter No. GHSB/632 dt. 25.02.2023 has conveyed that the applicant has not produced any document except two school leaving certificates having different D.O.B's and both the certificates are fake/false.

Now, Keeping in view of above facts, the claim for compassionate appointment under SRO-43 of 1994 in favour of Sachin Nayar S/o Late Sh. Rajinder Kumar (Ex- Safaiwala) GHS Birpur Zone Vijaypur R/o Ward No. 04, Dogra Hall Jammu is hereby rejected abinitio.
