- b) That he will give an undertaking in the shape of an Affidavit duly attested by the Executive Magistrate, 1st Class to the effect that if on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as MTS shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against the applicant.
- c) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) & (b) above are received in his favour.
- d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
