The appointee shall report to the Chief Education Officer, Poonch within a period of twenty one days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates;

- 3. Domicile Certificate.
- 4. Health Certificate from the concerned Chief Medical Officer of the District.
- 5. Dependent Certificate issued by the Assistant Commissioner Revenue.
- 6. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
- All other relevant documents as are required under SRO-43/1994.

The appointment of the appointee shall further be subject to the following conditions:-

- (a) That she shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate 1st class to the effect that:
- She is un-married, if adverse found at the time of appointment, then she shall have no right to Claim her appointment as Class-IV (Lab. Bearer) in School Education Department and her appointment, as such, shall be deemed to have been cancelled ab-initio;

If, on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Class-IV (Lab. Bearer) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.

- (b) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

This order is, however, subject to outcome of writ petition (s) if any, pending in any competent Court of Law.
