In terms of the J&K Compassionate Appointment Rules, 1994, notified vide SRO-43 dated 22-02-1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Mr. Sajed Mehsood S/O Late Sh. Mohd. Daud Ex-Teacher Govt. Middle School Chapper R/O Kotli Kalaban Tehsil Manjakote District Rajouri as Class-IV (Peon) in the pay scale of Rs.4440-7440 with grade pay of Rs. 1300/- in the School Education Department in District Cadre Rajouri under SRO-43 of 1994.

The appointee shall report to the Chief Education Officer, Rajouri within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates:

- Academic Qualification Certificates.
- 2. Age and Health Certificate.

- 3. Permanent Resident Certificate.
- 4. Dependent Certificate issued by the competent authority.
- 5. All other relevant documents as are required under SRO-43/1994
- 6. No Loan Certificate under Self Employment Scheme from DIC Concerned and Employment Department.

The appointee shall be initially on probation for a period of two years. If on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled abinitio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, CID, to whom a reference shall be made by the Chief Education Officer, Rajouri.

This order is, however, subject to outcome of writ petition if any, pending in any competent court of law.
