Sub: Registration of Private Tuition Centres governed by the J&K Regulation of Private Tuition Centres Rules of 2010.

NOTICE

Whereas, in terms of J&K Regulation of Private Tuition Centres Rules of 2010, no Private Tuition Centre can function without taking permission from the competent authority; and

Whereas, vide Govt. Order No. 389-Edu of 2015 dated 5/8/2015, Government has designated Director School Education, Jammu as competent authority to regulate the functioning performance of private tuition centres in Jammu Division; and

Whereas, Division Bench of the Hon'ble High Court in a PIL No. 17/2014 titled Mohd. Ahsan Untoo V/s State & others, appointed a committee comprising of two retired Judges for inspecting coaching centres and as per the Judges committee report, 123 coaching centres were found to be running not in conformity J&K Regulation of Private Tuition Centres Rules of 2010; and

Whereas, a show cause notice was issued to 123 proprietors of the coaching centre and in response to which only 98 proprietors furnished their replies; and

Whereas, replies furnished by the proprietors of the coaching centres were forwarded to the monitoring committee constituted vide Government order no.1056-GAD of 2015 dated 05-08-2015 for ascertaining the ground details as furnished in the replies; and

Whereas, the private coaching centres who have not furnished their replies have no legal right to continue and action under rules may be initiated against the defaulting Institutions; and

Whereas, the Hon'ble High Court vide order dated 13/12/2017 has issued the directions to Director School Education, Jammu/Kashmir to furnish the list of all the private coaching centres operating in their respective Divisions and further directed

Divisional commissioner, Jammu/Kashmir to constitute a team of two officers in their respective provinces who shall inspect the coaching centres and submit their detailed provided to the students, the position of the fee being charged and whether the applicable rules are followed strictly and further directed Divisional commissioners if any coaching centre is found not adhering to the rules he shall get particular centre sealed; and

Whereas, it has been found appropriate to give opportunity to proprietors of these private tuition centres to apply for registration after fulfilling the required criteria as stipulated in the said rules.

Now therefore, all the concerned are hereby informed through this notice to apply for registration of their respective tuition centres in the office of Directorate of School Education, Jammu within a period of 30 days along with the requisite formalities failing which it shall be presumed that they do not fulfil requisite registration criteria and necessary action under rules shall be initiated against them.
